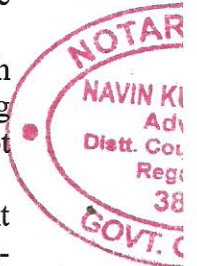
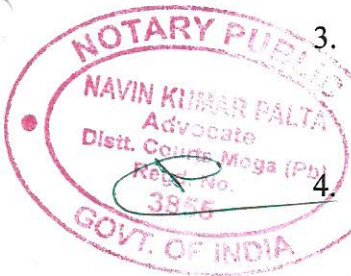



conditions:-

1. In case of any complaint/Inspection if this fact comes that you have given application with wrong information to the government at the time of taking No Objection Certificate and or you are not complying with the directions given by the panjab government from time to time and in this way written conditions in the affidavit are not obeyed, then in these circumstances this No Objection Certificate can be taken back any time.
2. In your school the teaching of Panjabi will be compulsory up to class tenth and C.B.S.E New Delhi will definitely make arrangements for taking Panjabi language exam. Alongwith this it is also said that if this is not done then No Objection Certificate will be taken back.
3. After taking affiliation from C.B.S.E New Delhi the school management will be liable to give pay scale and allowances to the teaching and non-teaching staff equal to the Panjab Govt. Scales. If this is not done then No Objection Certificate will be taken back.
4. You yourself and your management will make it sure that in case your district's District Education Officer or any senior officer of education department demands any type of information then you will provide him/her the required information and required help will also be given.

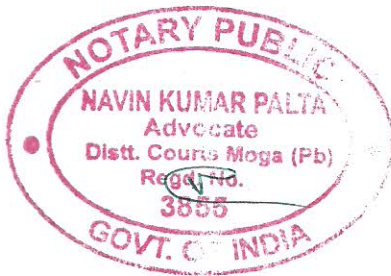
