- 9) That the school should not be closed without giving notices both to the parents, District Educational Officer, Srikakulam and competent authority atleast 6 months before.
- 10) All the conditions mentioned in the permission order should be fulfilled at the time of sanction of next recognition.
- 11) That the society shall submit proposals for renewals of provisional recognition sufficiently in advance ie atleast 6 months before the date of expiry of the provisional recognition.
- 12) Direct Admission should not made after vth class.

The Correspondent Varalakshmi Vidyashram up school G.R. Rajam (Un-Aided) is requested to improve strength in I to VIth classes other wise no further extention of recognition will be granted.

The Mandal educational Officer, MP, Rajam is requested to inspect the school and see that the conditions are fulfilled by the management and submit compliance report without fail.
